

## Wentworth Point Community Centre and Library (Community Hub) - CONDITIONS OF ENTRY

**Warami – “it’s good to see you”. Welcome to City of Parramatta.**

The following conditions of entry apply to all persons attending Wentworth Point Community Centre and Library (WPCCL) including general public, visitors, contractors and staff.

These Conditions of Entry should be read in conjunction with the Conditions under:

- The use for any service provided from within WPCCL (available on our website);
- any room booking as detailed through booking transactions and Terms and Condition;
- City of Parramatta’s Libraries Entry Condition and Guidelines;
- Programs, events and activities at WPCCL that may have specific additional conditions of entry, depending on the nature of the actual program, event or activity. These requirements will be clearly detailed through ticketing transactions.

### 1.0 General Conditions of Entry

By entering this premise (Hub), you agree to comply and be bound by the following Terms and Conditions of Public Entry:

- 1.1. A person must comply with any reasonable request- made by staff, including signage, in relation to entry, continued presence, or use of the Premises and its contents.
- 1.2. A person must not engage in behaviour that is likely to interfere with the safety, comfort or convenience of other people within the Premise or that is likely to damage or result in the unauthorised use of the Hubs facilities or materials.
- 1.3. Persons who cause a disturbance or refuse to comply with any requests made by Council staff or their agents will be denied entry or asked to leave the premises. Any person who attempts to enter the premises after being asked to leave will be immediately reported to the NSW Police;
- 1.4. All persons enter the premises at their own risk. To the fullest extent permitted by law, you release and indemnify City of Parramatta, its officers and affiliates from and against any injury, death, loss, costs, expenses, demands or liability, whether directly or indirectly, arising out of or in connection with your entry and use of this facility.



- 1.5. Smoking or the use of e-cigarettes is not permitted on the premises or outdoors within 4 metres of a pedestrian access point to the building;
- 1.6. Council reserves the right to search a person and reserves the right to inspect the belongings of all persons who enter or exit the premises and to exclude any bag or personal items while in the premises;

A person must not conceal their physical identity, either at the point of entry or while inside the premises. The City of Parramatta will respect cultural differences and medical conditions, but reserves the right to either refuse entry or remove anyone whose physical identity cannot be established.

- 1.7. A person must not leave belongings or personal items unattended;
- 1.8. Children Safety: Persons under the age of 12 must be under the direct supervision of an adult (18 years of age or older) at all times. Council reserves the right to contact parents or carers of any child under 16 years for whom there are concerns or to notify the appropriate agency if required;
- 1.9. If directed by Council staff or their agents, strollers and prams are required to be stored in the designated area;
- 1.10. For the safety and security of persons, closed circuit television cameras are in use in the premises. Any person entering the premises consents to and authorises Council to record or photograph you and to distribute video and images when required by an authorised officer or by law. All records are the sole property of Council;
- 1.11. Only authorised and site inducted contractors and their staff are permitted to work on the premises;
- 1.12. Persons must not engage in unauthorised political, promotional, charity or commercial activities in the premises without the consent of Council.
- 1.13. Persons agree to comply with any Public Health Orders, Restrictions and Guidelines issued and imposed by the NSW or Federal Government.
- 1.14. The above conditions are subject to change with no notice.
