### 1. Scope

This Policy forms the basis for managing asbestos in Council's local government area and is based on the NSW Office of Local Government's Model Asbestos Policy 2015 which is an updated version of the Model Asbestos Policy developed in 2012 to assist NSW councils to formulate an asbestos policy and to promote a consistent approach to asbestos management by Local Government across NSW.

The policy along with the Council's Asbestos Management Guidelines provides information for the local community and wider public.

The policy applies to friable, non-friable (bonded) and naturally occurring asbestos (where applicable) within Council's local government area.

The policy outlines the Council's commitment and responsibilities in relation to safely managing asbestos and general advice is contained within Council's Asbestos Management Guidelines. For specific advice, individuals are encouraged to contact the Council or the appropriate organisation.

The policy does not provide detail on specific procedures. Practical guidance on how to manage risks associated with asbestos and asbestos containing material can be found in the:

## 3. Policy

### 3.1 Policy Objective

This Policy outlines Council's commitment and responsibilities for safely managing asbestos.

## 3.2 Roles and responsibilities of Council

### 3.2.1 Educating residents

Council shall assist residents to access appropriate information and advice on the:

- prohibition on the use and re-use of asbestos containing materials;
- requirements in relation to development, land management and waste management;
- risks of exposure to asbestos;
- safe management of asbestos containing materials; and
- safe removal and disposal of minor quantities of asbestos containing materials.

Educational information and website links for educational materials can be found in Council's Asbestos management guidelines.

### 3.2.2 Managing land

The Council is responsible for managing public land. This may include land with naturally occurring asbestos and land contaminated with asbestos as outlined in Council's Asbestos Management Guidelines.

### 3.2.3 Managing Waste

Where the Council is the appropriate regulatory or planning authority, the Council is responsible for meeting certain obligations under relevant legislation by:

- issuing clean up notices to address illegal storage or disposal of asbestos waste or after an emergency or incident (under the Protection of the Environment Operations Act 1997);
- issuing prevention or clean up notices where asbestos waste has been handled (including stored, transported or disposed of) in an unsatisfactory manner (under the Protection of the Environment Operations Act 1997);

- issuing penalty infringement notices for improper transport of asbestos (under the Protection of the Environment Operations Act 1997); and
- applying planning controls to proposals to dispose of asbestos waste on-site, seeking advice from the Environment Protection Authority (EPA) on this matter and making notation on planning certificates (section 149 certificates) where on-site disposal is permitted.
- Contracting a private business that operates a licensed landfill facility/ facilities that accepts asbestos waste.

Waste facilities that are licensed to accept asbestos waste are listed in Appendix F in Council’s Asbestos Management Guidelines.

### 3.3 Regulatory responsibilities

The Council has regulatory responsibilities under the following legislation, and maintains policies and standards in situations where the Council is the appropriate regulatory authority or planning authority:

- Australian Standard AS 2601 – 2001: The demolition of structures;
- Contaminated Land Management Act 1997;
- Environmental Planning and Assessment Act 1979;
- Environmental Planning and Assessment Regulation 2000;
- Local Government Act 1993;
- Protection of the Environment Operations Act 1997;
- Protection of the Environment Operations (General) Regulation 2009;
- Protection of the Environment Operations (Waste) Regulation 2014
- State Environmental Planning Policy (Exempt and Complying Development Codes) 2008; and
- State Environmental Planning Policy No. 55 – Remediation of Land.

Additional legislation, policies and standards relating to the safe management of asbestos are listed in the Council’s Asbestos management guidelines.

The situations in which the Council has a regulatory role in the safe management of asbestos are listed in the Council's Asbestos management guidelines.

### 3.4 Responsibilities to workers

The Council is committed to fulfilling its responsibilities to workers under the NSW Work Health and Safety Act 2011 and NSW Work Health and Safety Regulation 2011 and maintaining a safe work environment through Council's:

- general responsibilities;
- education, training and information for workers;
- health monitoring for workers; and
- procedures for identifying and managing asbestos containing materials in the Council's premises.

These responsibilities are outlined in Council's Workplace Health & Safety Policies. (Available on the Council's website)

### 3.5 Other stakeholders involved in managing asbestos

The Council is committed to working collaboratively with other government agencies and where appropriate, other stakeholders as needed to respond to asbestos issues.

Please refer to the Council's Asbestos Management Guidelines for details of the agencies involved in managing asbestos. Various asbestos scenarios requiring stakeholders to work together are also outlined in these guidelines.

### 3.6 Complaints and investigations

Complaints and inquiries may be directed to the Council about incidents in public places and private properties. Complaints and inquiries regarding a workplace should be directed to SafeWork NSW. Complaints and inquiries regarding licensed premises under the Protection of the Environment Operations Act 1997 should be directed to the EPA.

The Council will respond to complaints and inquiries in accordance with the Council's Asbestos Management Guidelines and internal procedures regarding:

- the Council's requirements in relation to development, land management and waste management;
- derelict properties;
- general asbestos safety enquiries;
- illegal dumping;
- safe removal and disposal of minor quantities of asbestos materials; and
- unsafe work at a residential property conducted by a homeowner or tenant.

Complaints about the Council in relation to asbestos may be directed to the NSW Ombudsman.
