STAFF

Council's Transport Planner, Ms Myfanwy Lawrence, participated in the Australian Influentials Cycling Study Tour in September 2014 in the Netherlands. All land bound expenses in the Netherlands were met by the Dutch Government. The study tour was organised by the Cycling Promotion Fund. Ms Lawrence also visited Bordeaux France, Croydon England, Minneapolis and New York, USA in September 2014 to undertake a light rail study tour.

The total payment of expenses and facilities for Councillors of \$1,308,197 covers Councillor Support and Lord Mayoral Support.

WORKS CARRIED OUT ON PRIVATE LAND

EXTERNAL BODIES EXERCISING COUNCIL FUNCTIONS

To continue to monitor and prevent illegal dumping of waste and litter across the Local Government Area, Council, in alliance with other Western Sydney Councils, has delegated functions to the Regional Illegal Dumping (RID) Squad under the Protection of the Environment Operation Act 1997 and Regulations, the Environment Planning and Assessment Act 1979 and Regulations and the Local Government Act 1993 and Regulations.

CONTROLLING INTERESTS IN CORPORATIONS, PARTNERSHIPS ETC

Council did not hold a controlling interest in any corporations, partnerships, trusts, joint ventures, syndicates of other bodies during the year.

PARTICIPATION IN EXTERNAL BODIES, CORPORATIONS

Parramatta City Council is part of the Western Sydney Regional Organisation of Councils (WSROC) alongside Auburn, Bankstown, Blacktown, Blue Mountains, Fairfield, Hawkesbury, the Hills Shire, Holroyd, Liverpool and Penrith councils. WSROC's role is to identify regional issues and develop policy solutions that have an impact on member councils and residents

of Western Sydney. It is a key advisor on issues of regional importance such as transport planning, employment growth, population management and land use planning and development. WSROC also undertakes the procurement of goods and services for member Councils.

Council participated in Westpool for the provision of insurance services, along with Blacktown, Blue Mountains, Fairfield, Hawkesbury, Liverpool, Penrith, Shellharbour and Wollongong councils.

During 2014/15 Council participated in United Independent Pools (UIP) along with Auburn, Botany Bay, Holroyd, Hunters Hill, Lane Cove, Marrickville and

Rockdale councils. UIP provides a central coordinated range of risk management functions with the aims of reducing insurance costs through bulk purchase of insurance, centralisation of duplicated functions and obtaining economies of scale and improved efficiency.

Council holds a 50 per cent interest in Parramasala Limited, a company limited by quarantee. The other shareholder is Events NSW, a company formed to promote and deliver an Australian Festival of South Asian Arts staged in Parramatta.

Council participates in the procurement services of Local Government Procurement Pty Ltd, a business arm of Local Government NSW, the membership association for all councils in NSW.

Council is a member of the Greater Western Sydney Local Land Service (LLS) Local Government Advisory Group. This body delivers programs for environmental management to improve the condition of biodiversity and aquatic systems. The LLS also works with lead agencies such as the Rural Fire Service, State Emergency Service and Department of Primary Industries to assist with effective

responses to emergencies arising from natural disasters and biosecurity threats and manages pest animals in the region.

Council is represented on the NSW Public Libraries Association which represents the two peak library associations in NSW - Public Libraries NSW (representing rural and regional libraries) and the NSW Metropolitan Public Libraries Association (representing metropolitan libraries).

EQUAL EMPLOYMENT OPPORTUNITIES MANAGEMENT PLAN

Council has completed a comprehensive review of its Equal Employment Opportunities (EEO) Management Plan. Actions have been prioritised and we are in the process of implementing them. Council recognises that although women are well represented across the workforce and the Council staff base has a rich ethnic diversity, the Aboriginal and Torres Strait Islander (ATSI) Community and those with physical disabilities are not well represented in the current workforce makeup and more focus is required to improve said representation. Council has developed and adopted

an ATSI Employment Strategy and has correspondingly established a Steering Committee which comprises a diverse mix of members from within the organisation as well as two externally appointed members from Aboriginal employment and advisory bodies. The committee has met and to date has prioritised and commenced addressing actions within the strategy. Although yet to commence the formal development of a Disability Employment Strategy, discussions have taken place at various levels of the business to do so. Notwithstanding this, all actions within the EEO Plan and ATSI Employment Strategy continue to be worked on and will be implemented throughout the duration of the EEO Plan and ATSI Employment Strategy respectively.

CHIEF EXECUTIVE OFFICER & SENIOR STAFF MEMBERS' REMUNERATION

STORMWATER MANAGEMENT

Increasing urbanisation has resulted in a significant increase in impervious surfaces and has significantly increased the volume of stormwater flowing into urban waterways. These flows contribute substantial loads of litter, sediment and chemicals to urban waterways, as well as causing flooding in some areas of Parramatta. In addition, appropriate asset management (through maintenance and replacement of drains and stormwater treatment measures) and the harvesting and reuse of stormwater is becoming increasingly important.

To assist councils with the funding of significant capital investments required to ensure effective stormwater management services, Government has given NSW councils permission to levy additional charges.

Parramatta City Council administers a comprehensive waterways management program that is underpinned by our long-term *Rivers of Opportunity Strategic Plan.* A database of prioritised waterways activities required to fulfil the plan is being implemented as available funds allow. As the principal authority responsible for the management of stormwater, we:

- » maintain 438km of stormwater discharge drainage pipes for stormwater conveyance
- » implement essential flood mitigation measures to protect life, property and infrastructure
- » conserve the natural waterways of the City
- » protect bushland and other natural assets from the impacts of urban runoff by implementing purpose-built pollution control traps and water retention systems.

The capital and operational costs associated with natural and built stormwater infrastructure throughout the City of Parramatta for 2014/15 was over \$3.6 million. This cost includes upgrade of drainage systems, management of natural riverbank (riparian) areas, flood mitigation programs and the construction and cleaning of pollution control devices within the public domain. As systems are upgraded and improved, additional maintenance burdens arise which necessitate the dedication of a sustained source of funding for stormwater management.

In 2006/07 Council introduced a Stormwater Management Service Charge in accordance with the *Local Government* Amendment (Stormwater) Act 2005. This charge funds service enhancements such as: drainage infrastructure and pollution control device maintenance, creek rehabilitation works associated with stormwater discharges, stormwater reuse in community facilities and stream health monitoring.

The annual approved budget from this charge in 2014/15 was \$1,242,932. A total of \$1,366,363 was spent across these six areas in 2014/15 with the over expenditure to be drawn from the balance of funding in the externally restricted reserve (see Table 1).

COMPANION ANIMALS ACT

Councils are required to include in their annual reports a detailed statement of their activities during the year relating to enforcing and ensuring compliance with the Companion Animals Act and Regulation (CAA).

Council has lodged data regarding each reportable dog attack – 37 in total for the financial year. These are lodged through the Companion Animals Register as per legislative requirements.

Total expenditure on Animal Management activities was \$467,000. Pound costs increased substantially from the previous financial year, now \$250,000. Officers' salary costs for 3 officers were \$210,000 and ancillary costs were \$3,000.

Council promoted various subsidised desexing programs offered by AWL and RSPCA etc. on a one on one basis with our residents. Council staff attended community events for various charity/ rescue groups to provide education regarding the CAA and free microchipping service

Council currently uses Blacktown

City Council's Animal Holding Facility (BCCAHF) which holds, releases, sells, rehomes or euthanases all companion animals from Parramatta LGA including animals that come in from residents and Council staff, BCCAHF uses a number of reputable rescue groups for any unclaimed animals in order to prevent their euthanasia. The euthanasia rate for rehomable dogs for the last financial year was 3.7%. The euthanasia rate for cats was 58% overall, however this is mainly due to 'feral' cats brought in by the public which are unable to be rehomed. The euthanasia rate of rehomable cats was only 3.2% for the same period. Council also uses its own temporary holding facility where applicable/possible for reuniting pets with their owner and therefore avoid animals entering BCCAHF where fees apply and due to financial hardship may not be claimed. Council has also formed working relationships with a number of reputable rescue groups for assistance in taking on kittens and other animals at high risk of not being claimed or rehomed i.e. dumped/timid/ old animals. This further helps reduce the euthanasia rate.

Council Animal Management Officers have attended several public education days with animal welfare organisations to educate companion animal owners in responsible animal husbandry and control. As part of this education service, free micro-chipping was offered to improve animal registration and identification. Funds were also expended in the construction of a short term animal holding facility purpose built at the Rydalmere Operations Centre to aid in the reuniting of animals with their owners without having to be taken to the Blacktown Pound incurring additional expenditure.

REPORT ON SPECIAL VARIATIONS TO RATES INCOME

In 2011 the Independent Pricing & Regulatory Tribunal (IPART) approved the following Special Rate Variation:

- 1. A 3% variation over and above the forecast rate peg amounts for a period of 3 years (3 annual variations of 1% commencing 2011/12 - based on a total increase of 4.3% per year incorporating a rate-peg assumption of 3.3%).
- 2. A special variation of 4.9% in 2013/14 to enable the continuation indefinitely of the time limited special variation approved in 2010.

The Council uses the additional income for the purposes of:

- Improving the Council's financial sustainability
- Funding the CBD Infrastructure Program and Economic Development Program

Funding an additional \$7m on capital expenditure on asset replacement and maintenance from 2015/16 and maintained in following years.

Council reports in its annual report for each rating year over the period from 2011/12 to 2020/21 on:

- a. Programs of expenditure on the CBD Infrastructure and Economic Development Programs
- b. Outcomes achieved as a result of the special variation including progress made in improving the Council's financial sustainability
- c. Asset renewal and maintenance expenditure
- d. Actual productivity savings achieved
- e. Any significant variations from its financial results as forecast in its Long Term Financial Plan and any corrective action taken

A. (I) CBD INFRASTRUCTURE PROGRAM EXPENDITURE

In 2014/15 \$7,172,608 was expended on the CBD Infrastructure Program. The major works completed included the following:

Outcomes Achieved

- Improvements in Macquarie and Charles Streets and Wigram Street at Harris Park were made. The Wigram Street upgrade is a 2 year program of works that seeks to provide additional neighbourhood amenity and economic vibrancy through streetscape upgrade that allows the footpath design to incorporate outdoor dining.
- » The completed upgrade of Centenary Square will improve the perception and experience of Parramatta City centre as well as encourage pride and social economic activity. This is the transformation of one of the most important public domain areas in Parramatta.
- Stage 1 of the Citysafe Video Surveillance System has been completed with the construction of a fiber optic network linking 55 high definition surveillance cameras in Parramatta CBD.
- » The Parramatta War memorial Upgrade at Prince Alfred Square

- involved additional paving and upgrade works in preparation for the Centenary of ANZAC service held on 25 April 2015.
- » The CBD foreshore reserve south remediation involved remediation of contaminated soil within landscaped garden beds.

A (II) ECONOMIC DEVELOPMENT PROGRAM EXPENDITURE

In 2014/15 \$632,244 was expended on the Economic Development Program. Part of this expenditure was funded from rates collected in previous years and held in reserve.

Outcomes Achieved

During this financial year the focus has been assisting with the We're Building Australia's Next Great City campaign, with the support of a number of small business partners. Achievements include:

» The Centenary Square area has hosted a range of significant events and every day there are residents, visitors and business operators using this space.

- » Support of the SmallBiz Connect program run through UWS and sponsorship of a small business course aimed at creative industries, the Parramatta Business Expo and the Office of the Small Business Commissioner's SmallBiz bus.
- Support of a number of different activities associated with identifying the skill shortages in Parramatta, assisted UNSW to research youth unemployment in Parramatta, undertook a broad perception survey of the impact of the new brand campaign.

B. IMPROVING COUNCIL'S FINANCIAL SUSTAINABILITY

The additional variation relating to ordinary rates income has helped improve Council's financial performance by achieving a surplus for the year 2014/15. Council's adjusted operating surplus (excluding capital items and one-off receipts and payments) was \$0.973 million. This surplus was an increase of \$0.5m from the previous year.

C. ASSET RENEWAL AND MAINTENANCE EXPENDITURE

In 2014/15 Council expended \$35.4 million on asset renewal and \$10.0 million on maintenance compared with \$28.2 million and \$5.6 million respectively over the previous year.

Council has allocated an additional \$20 million on asset renewal as outlined in Council's Long Term Financial Plan and Strategic Asset Management Plan from 2012-2015

D.PRODUCTIVITY INITIATIVES/ SAVINGS ACHIEVED

Examples of productivity improvements and savings achieved, by strategic priority include:

Connectivity

- » New installation of "Tap n' Go" technology rolled out to all the parking meters, with the multi-level car park upgrade to follow provides convenient experience to customers.
- The enhanced version of the MyParra mobile app (three new functionalities added) has been published in the Apple, Android and Windows stores. The same functionalities were also implemented and available in the Parramatta internet site.

Environment

- » Corporate sustainability programs completed included energy and water efficiency upgrades at Riverside Theatres, the CBD multi-level car parks, park amenity buildings and child care centres. Sustainability has also been integrated into the design of buildings in Parramatta Square and the newly constructed Rydalmere Operations Centre (ROC).
- Waste diversion rate of approximately. 44% for the 2014/15 year including around 5,000 tonnes processed and recovered through the UR3R AWT at Eastern Creek. Recycling and green waste diversion of around 25,000 tonnes for the year together with approximately. 7,000 tonnes of kerbside clean-up of which over half was diverted from landfill.

Leadership and Governance

- » Online process for resident parking permit renewals and pensioner rebates have been completed to provide additional online services as part of the customer contact portal.
- » Council went live with an on-line service for s149 (2) certificates. It is estimated that over half of Parramatta properties can access the new service, which is phase 1 of an intended 4 phase project.

Culture and Sport

» Social media and blog posts enhanced to promote Parramatta's history through the Research Services web page. arc.parracity.nsw.gov.au was developed and includes topics such as WW1 research of Parramatta service men & women, Parramatta Stories, Centenary Square, River Foreshore and Parramatta Gaol.

People and Neighbourhoods

- A 20% improvement in partnership programs targeting children and multicultural programs.
- Launch of a weekly Community Funding e-Newsletter which now has 1,250 subscribers with an average opening rate of 27%
- A variety of educational, recreational and life skills programs, events and exhibitions to build community capacityover 1451 programs were offered in 2014-15 with 37,799 attendees, an increase of 4% over the previous year.
- Based on face to face exit surveys at the Customer Contact Centre. 90% of customers waited less than 5 minutes with overall customer service experience rated as excellent or very good (98%)
- Change of Name and Address is now live on both the Website portal and My Parra app. Resident Parking Scheme Renewal process is now live on the Website portal as is the Statement of Rates & Charges (603 Certificate) automation.

E. SIGNIFICANT VARIATIONS FROM FINANCIAL RESULTS AS FORECAST IN THE LONG TERM FINANCIAL PLAN AND CORRECTIVE ACTION

Council reported a net operating result of \$23.3m. This is 52.9% or \$8.0m over the original budget. Total revenue was 9.0% or \$18.3m over budget while total operating expenses were 5.5% or \$10.3m over budget. Significant variations included:

- Materials and Contracts expenses \$4.524m, 12.4% higher than budget, compared with original 2014/15 budget mainly due to various consultancies including a CBD Planning Framework Study which required a dedicated project team, technical studies to amend planning controls in the Parramatta city centre, Fit for the Future research and advice. engagement of services of a law firm in lieu of in house legal counsel and Land and Environment court costs.
- User charges and fees revenue were \$4.863m, 17.2% higher than budget due to higher revenue from swimming centres, Development Application fees, rezoning fees, road opening permits, construction zone fees brought about by increased development and construction activity during the year.
- Interest income was \$2.3m, 42.2% over budget. This is due to a very large increase in the base investment portfolio related to the sale of Bartlett Park. This increased interest income despite lower interest rates during the period.
- Other revenue was \$1.4m, 13.6% under budget due to lower parking fine revenue, parking SEINS and other fines below budget brought about by changes in business practices and a number of vacant positions in the Regulatory area that remained unfilled filled during the financial year.

CARERS (RECOGNITION) ACT

During 2014-2015 the Carers Support service was provided to approximately 91 carers to support them to maintain their health and wellbeing and caring role. This involved 1,243 hours of support including support groups twice a month with an educational focus on self-care, wellness, resilience and strengths building, as well as monthly newsletters that keep carers informed and up-to-date with the latest information and resources, and individual support to help them achieve their goals in particular, having a holiday or short respite break, and expanding their networks for increased social connection. Most importantly, enabling carers to balance their own needs while caring for the person they support.

Council's new service delivery model has involved increasing support by partnering with the whole family (including carers) that has improved outcomes for the older person or person with a disability and their family. The aim being that both the person receiving support and the carer are able to achieve their own goals toward having a good life.

Carers are identified by all services and appropriate referrals are made to support their needs. Each year the service celebrates Carers Week with a free outing for carers and recognition by Council.
