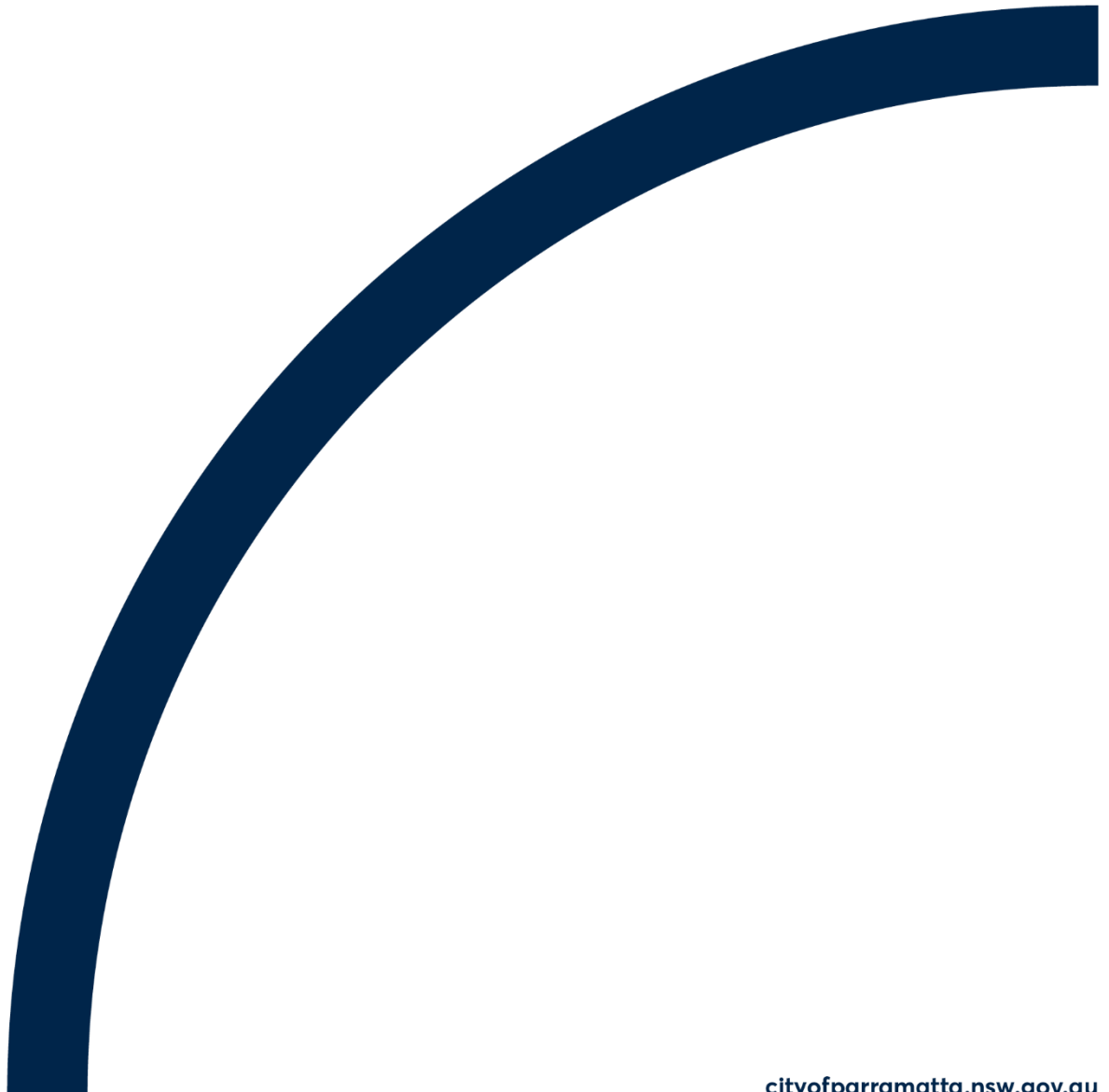


# **How to Track an Application via DA Tracker**
